**Parrots in Paradise Sanctuary, Inc. agrees to provide for the adoption of, and Adopter agrees to adopt the parrot described above according to the terms and conditions set forth herein:**

**The Parrot you are adopting has been surrendered, abandoned, or in some way displaced. It may have been abused or neglected. There may be limited, if any information available regarding the parrots' previous environment. Parrots in Paradise Sanctuary, Inc. does not guarantee, nor is it responsible for the temperament or health of this parrot. There will be an adjustment period. Remember to be patient, consistent and understanding.**

- 1. Adopter agrees that this parrot will not be intentionally used for breeding or put on public display for the purpose of monetary compensation or as an attraction at any time under any circumstance.**
- 2. Adopter agrees to accept this parrot as a companion to live in Adopter's home. Adopter agrees to provide this parrot with proper food, water, veterinary care, and loving attention. Adopter agrees to keep this parrot in a large cage and provide adequate perches. Adopter agrees to obtain pertinent information regarding the proper care of this parrot as needed.**
- 3. Adopter understands that it is possible for a parrot to be a carrier of, or infected with a disease that is undetectable or difficult to diagnose. Adopter understands that Parrots in Paradise Sanctuary, Inc. is not responsible for any incidence of disease in the adopted parrot which may be detected or diagnosed at any time after the adoption.**
- 4. Adopter shall allow Parrots in Paradise Sanctuary, Inc. the right to make an inquiry about this parrot at any reasonable time. Adopter shall return this parrot to Parrots in Paradise Sanctuary, Inc. if it is determined that the parrot is not receiving proper care.**
- 5. Adopter agrees that if at any time the Adopter is unable to keep this parrot, Adopter shall contact Parrots in Paradise Sanctuary, Inc. and arrange for the parrot to be returned to Parrots in Paradise Sanctuary, Inc. Adoption fees are not refundable under any circumstance.**
- 6. Adopter agrees that no claim or legal action will be taken against Parrots in Paradise Sanctuary, Inc., its officers, or agents by reason of this adoption or any action of this parrot. Adopter accepts full responsibility of this parrot and its actions.**

7. Adopter promises to comply with the laws and ordinances enforced in the state and municipality in which Adopter resides.
8. Adopter agrees to feed the parrot a diet consistent with that being fed by Parrots in Paradise Sanctuary, Inc.
9. In the event of the death of this parrot, the Adopter agrees to contact Parrots in Paradise Sanctuary, Inc. immediately or in a reasonable period of time to determine the cause or manner of death.
10. Adopter agrees to contact Parrots in Paradise Sanctuary, Inc. for any questions or concerns regarding the well-being or health of this parrot.
